Physical Planroom

The planroom is available to Members of LAXBX weekdays from 8 am to 4:30 pm, except certain holidays. Any persons using the planroom must be employed on the permanent staff of a LAXBX Member. Each person entering the planroom must sign the plan room daily register. Planroom privileges may be suspended or revoked for any Member not in good standing with LAXBX, or whose representatives abuse the planroom. Plan room privileges may be suspended or revoked for any Member deliberately removing plans or specs from the plan room without prior authorization from the staff.
